**Initiation Fees**

General Memberships require payment of a one-time Initiation Fee in the amount stipulated at the time of the application. This fee is **non-refundable** and must accompany the application.

**Terms and Conditions**

General Members may pay quarterly (with an additional \$25 per quarter fee) or pay the entire annual dues at once. Annual membership payments are due on January 1; quarterly membership payments are due on January 1, April 1, July 1, and October 1. Membership payments are considered delinquent 30 days after the due date and result in an immediate suspension of membership privileges. A \$25 late fee will be assessed on all delinquent payments. Failure to remit dues by the end of the quarter will result in the termination of membership. Reinstatement requires payment of all back dues within the past 12 months. Members who are suspended for one year must make application as a new member and pay the appropriate initiation fee. All resignations are requested to be in writing. Dues payments may be made by cash, check, debit card, or credit card. A 2.9% administrative fee applies to all credit and debit card payments. Credit and debit cards must be presented in person.
