Reinstatement requires payment of all back dues within the past 12 months. Members who are suspended for one year must complete a new application. All resignations of membership must be in writing. Dues payments can be made by cash, check, debit, or credit card. A 2.9% administrative fee will be applied to all debit and credit card payments. Credit and debit cards must be presented in person.
